## "TwoEA-M" PROJECT ON ENVIRONMENTAL ASSESSMENT AND MANAGEMENT HIGHER EDUCATION LAUNCHED

In December 2008, an EU-funded project titled "TwoEA-M" (Enhancing Attractiveness of Environmental Assessment and Management Higher Education) was launched. During its two year lifetime, its objectives are 1) to establish a European and East-Asian network on environmental assessment and management (EAM), 2) to prepare an overview of EAM master programmes throughout the EU, 3) to organize conferences (three in Asia, one in Europe) on East-Asian and European EAM interests, and 4) to elaborate a report on specific East-Asian EAM interests and education requirements.

The project consortium consists of The University of Liverpool (**Thomas Fischer, Urmila Jha-Thakur**), the University of Technology Bratislava (**Ingrid Belcakova**), and the Austrian Institute for the Development of Environmental Assessment (**Ralf Aschemann**), supported by EAM institutions in South Korea, Malaysia/Thailand, Japan and China. ## ENVIRONMENTAL ASSESSMENT REGULATORY REFORM AND ECONOMIC STIMULUS IN CANADA

In March 2009, the Government of Canada made changes to the Canadian Environmental Assessment Act (CEAA) regulations to expedite the flow of federal infrastructure funds as a stimulus during the current economic downturn.

The first change adds to the Exclusion List Regulations projects that are triggered by federal funding from the Building Canada Plan. Certain projects (e.g., municipal water works, roads and light rail transit), but not all, are now exempt from CEAA. The second change allows provinces to substitute their EA process for the federal process in part, and with conditions, for some federally funded projects. These regulations should streamline and shorten the EA process for infrastructure projects.

AECOM is currently providing guidance to public sector clients concerning these regulations. Specifically, AECOM is delivering solutions that consider the environmental effects of these projects, while realizing the benefits of the EA regulatory reform. ## A HIGHER PROFILE FOR RESEARCH IN IAIA

Although research is an essential component of the IAIA community, it is often surprisingly difficult to meet other researchers and discuss common issues of research practice, or new directions in impact assessment research. We feel it is an appropriate time to look more closely at research, and researchers, in IAIA, and see if we can provide better opportunities for researchers to communicate more effectively within the organisation. Particular benefits would include:

- Discussing potential research topics, comparing methods and approaches, exploring possible collaborations, across countries and/or across different areas of impact assessment.
- Fostering/mentoring research in developing countries, or among early career researchers.
- Encouraging graduate students to pursue impact assessment topics, assist their networking, and provide career development support and advice (working with the SEP Section).

What might we do? One suggestion we have is to organise a workshop at the Geneva conference specifically to address the broad issue of research in impact assessment. ## FROM THE PRESIDENT



IAIA09 in Accra achieved its primary aim of bringing together IA practitioners from Africa as well as other parts of the world with half the registered participants from the African region. The conference built strongly on the CLEAA (Capacity Development and Linkages for Environmental Assessment In Africa) initiative. We addressed the important theme of “impact assessment and human well being,” encouraging presenters to consider the important human dimension when analyzing impacts of all types. The theme promoted consideration of integrated approaches to longer-term issues of sustainability.

Our heartfelt thanks go to local committee members, individuals, sponsors of the conference and capacity building, and HQ staff for making IAIA09 a success.

Thoughts of members now turn to the theme for next year’s conference, where we are considering the role of impact assessment in “Transitioning to a Green Economy.” As countries and international organizations respond to the global financial crisis (GFC), we must support proactive application of IA to ensure economic policy initiatives have sustainability outcomes built into them from the start. Let’s engage actively and constructively in thematic debates prior to, at, and outside the conference itself.

One consequence of the GFC could be attempts to “wind back” on IA processes and applications—for instance, wind back capacity building, insufficient funding of IA, timelines that are unrealistic, limiting the scope of procedures, and changes to IA legislation. We ask members to identify and document instances to myself (n.taylor@tba.co.nz), **Peter Croal** (peter\_croal@acdi-cida.gc.ca) or **Rita Hamm** (rita@iaia.org) at IAIA HQ. Our aim is to report back at Geneva and discuss there the implications of wind back for IA practice.

The annual conference is the major activity and the “face” of IAIA. We are working to improve conference quality and affordability, so Accra participants please give us feedback by completing the evaluation form online (follow the instructions sent in your survey invitation e-mail). An innovative and continuing aspect of the IAIA conference is peer review of the major presentations. The review process has been successful as part of the effort to achieve high quality conference content.

We must remember that “integrated” assessment and “sustainability” have always been core to IA. An integrated approach has a number of essential dimensions that help provide sustainability outcomes:

- IA is fully integrated into planning and decision making processes, particularly into design (formulation) and implementation phases.
- The technical elements of IA, covering social, economic, health and bio-physical dimensions of the environment are included conceptually and in practice, so that analysis is not confined to specialist spheres, and chains of cause and effect are always considered.
- Public involvement processes are always integrated with the IA process.
- There is full integration between strategic and project-programme applications of IA, with strong feedback loops into the policy making process.
- Capacity building is included in the IA process so that all stakeholders are enabled to take part in planning and decision making processes.

As a priority, we ask all members to continue to work hard at building IA networks and membership. The Board encourages national or regional networks of IA to formalize and become Affiliates of IAIA. If you have any questions about becoming an Affiliate, please contact Board member **Júlio Jesus** (julio.jesus@netcabo.pt) or **Rita Hamm** at HQ. We are also promoting our new corporate membership categories, while looking at ways to support our corporate members to fully adopt IA processes and strengthen their social and environmental performance. I urge members to take an active part in IAIA during the year before we meet in Geneva and in setting a high standard for IA internationally.

## TECHNICAL VISIT REVIEW

**DELEGATES HAVE A WIDE RANGE OF EXPERIENCES DURING A FULL DAY OF TOURS**

Our Ghana EPA technical visit hosts, Leticia and Clement, arranged a full day of technical visits of industrial sites ranging from the Tema Oil Refinery, Cargill Cocoa Processing Facility, and the Port Authority to the Tilbury Port Reception. Our last stop was at the Cocoa Processing Company. In addition to learning about some of the company's environmental management procedures, we were able to stop at the chocolate shop. The chocolate purchased here is now being enjoyed all around the world—Sudan, Bulgaria, Canada, United States, Thailand, Netherlands, Philippines, and many more countries!

The photo below shows the group at the Cargill Cocoa Processing Facility where cocoa powder and cocoa butter are produced. Cargill explained the environmental assessment process for the relatively new plant. As part of the assessment process, the design team was able to reduce the number of cooling towers in order to reduce water consumption. The facility was designed to use cocoa husks as a fuel source at the plant.

## TRANSITIONING TO THE GREEN ECONOMY

The 30th annual conference of IAIA, IAIA10, in Geneva will focus on five sectors that have tremendous potential for green investments: sustainable agriculture, cities and buildings, industry, transport, and tourism. Discussions at the conference (and before!) will highlight each of these sectors with emphasis on specific areas such as trade and aid, finance and governance, health, poverty and employment, and tools/methods. One day of the conference will be devoted to each of the following:

- Current challenges and environmental, social, and economic impacts.
- What needs to be done (proposed policies and measures; role of government, private sector, finance, NGOs and IGOs).
- Potential impacts: environmental (natural resources, ecosystem and the services it provides), social (employment, equity and poverty reduction considerations) and economic (trade, stimulating and diversifying economies, and sustainable development).

The intended outcome of IAIA10 is to provide relevant strategies for decision-makers struggling with the complexities of the economy and the environment. In order to do this in a timely manner, the plan is to have the papers available ahead of the conference. So, the early dates for abstract and paper submissions not only allow for sufficient time for the review process and submission of papers, but also electronic discussion and review of the papers by everyone even before the conference begins.

The prevailing economic and environmental crises are global. They have everyone's attention around the world—especially that of the media and governmental decision makers. IAIA10 provides a rare opportunity for IAIA members to show how the application of the tools and methods of impact assessment can help government and business adopt strategies that will lead to economic and environmental sustainability.

## IAIA10 CALL FOR TRAINING COURSE PROPOSALS

IAIA's training courses are an important element of the Association's continuing effort to promote and advance professional development and excellence in impact assessment. In 2010, IAIA again plans to organize high quality training courses in association with its annual conference. The Board of Directors and the Training and Professional Development Committee (TPDC) are therefore inviting proposals for training courses to be delivered at the 30th annual conference, which will be held in Geneva, Switzerland, 6-11 April 2010. It is anticipated that training courses will be delivered as part of the pre-conference program 6-7 April.

Training courses may cover any aspect of impact assessment, but priority will be given to proposals that address member-driven demand for intermediate and advanced level training and for courses on the topics listed below (the list is not exclusive). Proponents who have previously taught courses at IAIA conferences are encouraged to upgrade and/or innovate the content and level of the course to allow previous participants to attend the courses again.

1. Policy engagement: How to influence policy-making through innovative use of IA
2. IA and climate change, mitigation, and adaptation
3. Sector-specific IA (e.g., mining, oil and gas)
4. Cultural component of impact assessment
5. Sustainability assessment
6. Strategic Environmental Assessment
7. Health impact assessment
8. Participation and indigenous people in IA
9. Social impact assessment
10. IA in developing countries
11. Integrating biodiversity in IA
12. Quality review and auditing for impact assessment
13. Cumulative effects and follow up in impact assessment
14. Tools for impact assessment (e.g., resource economics, GIS, IT)
15. General professional capacities (e.g., ethics, leadership, capacity building)
16. Environmental management plans and systems

Proposals must be submitted to IAIA Headquarters ([jen@iaia.org](mailto:jen@iaia.org)) by 14 August 2009 and should comply with the complete structure and content requirements provided online ([www.iaia.org](http://www.iaia.org) > IAIA10 > Program > Training Course Information). Failure to provide adequate documentation will result in the rejection of a proposal. Please do not simply copy and resubmit prior proposals, as the courses offered need to be innovative as well as up to date. Course proponents will be notified about the outcome of their application by 15 September 2009.

## A higher profile for research *(Continued from page 1)*

A second suggestion is to be more proactive and to develop a specific research programme that would run through IAIA over the next few years, and use that as a vehicle to help develop the networks within IAIA. To that end, we have been exploring the possibility of a research theme called "Impact Assessment as a Learning Process." Rather than focusing, as a good deal of IA research does, on the mechanics of IA (legislation, procedures, capacity building, etc.), a learning perspective would consider how the long term behaviour of all actors in the IA process is affected by their experiences with the process: how do people learn, does it provide positive or negative feedback, can learning be managed, etc.? Learning is well established in certain areas of IA research (e.g., social learning and community participation; organisational learning), but we are suggesting extending the concept across all aspects, and all actors, to provide a powerful integrating framework that would also suggest new directions for research. It would also be a valuable way to compare IA systems and effectiveness in different countries.

We are inviting interested researchers to join us in developing this programme. If there is sufficient interest, we will seek IAIA Board recognition of the activity as an official IAIA project and develop an implementation plan that would lead to the production of an edited book in two to three years' time. This would be a worthwhile outcome in itself, but we also see this as a vehicle for developing the research community in IAIA and enhancing the international profile of IAIA.

# ECONOMIC MELTDOWN AND THE FUTURE OF IMPACT ASSESSMENT

## WHAT IS THE ROLE OF IMPACT ASSESSMENT FROM THIS POINT ON?

The last 18 months have seen an unprecedented restructuring of the global economy. Thousands of jobs have been lost, many countries now run massive deficits and many forms of panic and worry pervade the market place. Coupled with this is the real effect of climate change starting to take hold and publics all over the world who are starting to believe that their interests are not being respected. Our hardwired attributes of trust and fairness are under siege. The world is changing from an environmental and financial perspective, and very rapidly. If one were to have a conversation today with the private sector, insurance company or commercial bank, I suggest that there would be a heightened focus on the aspect of minimizing risk in

a somewhat unstable and changing world.

Therefore, what is the role of impact assessment from this point on? Should practitioners focus even more on risk management? Do we need to adjust our practice to reflect the current reality? Are more "tools" needed or rather, a harmonization and rationalization of impact assessment practice that can reach, and speak to a wider audience?

Please send your thoughts and ideas to **Peter Croal**. This may lead to a more focused exploration of this issue at IAIA10 in Geneva.

## HEALTH: HIA PRACTICE STANDARDS ISSUED BY NORTH AMERICAN GROUP

A working group established at the first North American Conference on Health Impact Assessment held September 2008 in Oakland, California, has issued a first version of practice guidelines, entitled "Practice Standards for Health Impact Assessment (HIA)" (available at [www.sfphes.org/HIA\\_Practice\\_Standards.htm](http://www.sfphes.org/HIA_Practice_Standards.htm)). This was a collective endeavor under the leadership of the San Francisco Department of Public Health.

At the conference (see the story in the IAIA Newsletter from January 2009), there was significant discussion around the issues of quality, standards and values in the conduct of HIA. Participants strongly felt the need for standards or benchmarks to clearly establish HIA quality. Without practice standards, it was felt the term HIA may become ambiguous and the practice misused or vulnerable to criticism.

The document is short—11 pages in total—and attempts to translate the values underlying HIA into specific "standards for practice" for each of the five typical stages of the HIA process. These standards may be used by practitioners as benchmarks for their own HIA practice or to stimulate discussion about HIA content and quality in this emerging field.

Many of the organizations involved in the Conference have signed on as signatories, including the University of California Health Impact Group, Human Impact Partners, Habitat Health Impact Consulting, Environment Resources Management, and the San Francisco Department of Public Health, as well as a number of individual participants listed in the document.

The authors and signatories do not claim to have achieved all of these standards in our work to date. We recognize that real-world constraints will result in diversity of HIA practice. Overall, we hope these standards will be viewed as relevant, instructive and motivating for advancing HIA quality rather than rigorous criteria for acceptable or adequate HIA.

We also hope this document may provoke discussion on whether international practice standards for HIA are needed. Comments and suggestions for future versions of the Practice Standards are welcome.

AEEIA also took the opportunity to gather those attendees from Latin America and put forward an initiative to create an Iberoamerican net-

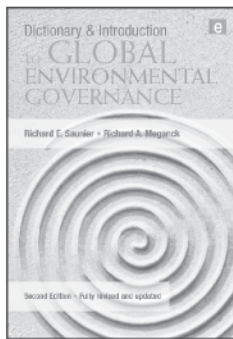

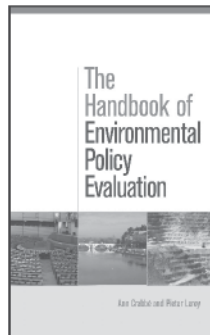

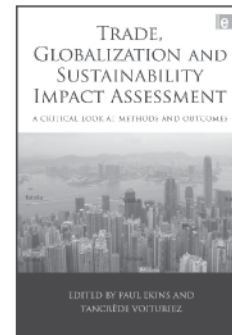

## THE BUSINESS AND BIODIVERSITY OFFSETS PROGRAM—FORGING AHEAD

The Business and Biodiversity Offsets Programme (BBOP) is a partnership of some 40 leading organisations and individuals including companies, governments, conservation experts and financial institutions from around the world.

Biodiversity offsets are measurable conservation outcomes resulting from actions designed to compensate for significant residual adverse biodiversity impacts arising from project development after appropriate prevention and mitigation measures have been taken. The goal of biodiversity offsets is to achieve no net loss and preferably a net gain of biodiversity on the ground with respect to species composition, habitat structure, ecosystem function and people's use and cultural values associated with biodiversity.

BBOP envisages a future in which biodiversity offsets are applied worldwide to achieve no net loss and

preferably a net gain of biodiversity relative to development impacts. Its mission is to provide leadership in the establishment of biodiversity offsets as a widely recognised and applied tool by developing and promoting best practice, based on agreed principles.

The first phase of BBOP's work (2004–2008) has concluded, and the group has just released a set of publications that capture emerging thinking on the principles and methodologies that support best practice in biodiversity offsets. BBOP is embarking on an ambitious next phase (2009–2011) and would like to broaden its circle of collaborators, working more closely with impact assessment professionals.

Priorities for BBOP's work to 2011 are to:

- Develop verification and auditing protocols.
- Establish a broader portfolio of biodiversity offset experiences.
- Improve the guidance on biodiversity offsets.
- Support policy measures at the national level.
- Explore aggregated offsets and conservation banks.
- Undertake training and capacity building.
